### **General Details / Operating Condition:**

From 0700hrs 17<sup>th</sup> May 2024 to 1800hrs 20<sup>th</sup> May 2024 the Dandaloo Street level crossings (497.629km) at Narromine will be temporarily closed to all road and pedestrian traffic. During this period, road traffic will be prevented from accessing the level crossing as detailed in the relevant traffic management plan.

The pedestrian level crossing located at (497.651km) will remain available for use by pedestrians from:

- 0700hrs 17 May 2024 to 1800hrs 17 May 2024,
- 0700hrs 18 May 2024 to 1800hrs 18 May 2024,
- 0700hrs 19 May 2024 to 1800hrs 19 May 2024,
- 0700hrs 20 May 2024 to 1800hrs 20 May 2024.

Handsignallers will be provided to manage the pedestrian level crossing.
